

THIRD AMENDMENT TO AGREEMENT FOR DRY CARPET CLEANING SERVICES - CITYWIDE

THIS THIRD AMENDMENT TO AGREEMENT FOR DRY CARPET CLEANING SERVICES - CITYWIDE ("Third Amendment") is entered into by and between **CITY OF OCALA**, a Florida municipal corporation ("City"), and **CUBIX, INC.**, a for-profit corporation duly organized and authorized to do business in the State of Florida (EIN# 59-3069016) ("Vendor").

WHEREAS, on July 19, 2021, City and Vendor entered into an Agreement for Dry Carpet Cleaning Services - Citywide (the "Original Agreement"), City of Ocala Contract Number: FAC/210090 for a term of three (3) years, from May 18, 2021 to May 17, 2024; and

WHEREAS, on May 15, 2023, City and Vendor entered into a First Amendment to Agreement for Dry Carpet Cleaning Services - Citywide ("First Amendment") adding two additional cleaning areas and to modify pricing and maintenance schedule; and

WHEREAS, on May 9, 2024, City and Vendor entered into a Second Amendment to Agreement for Dry Carpet Cleaning Services – Citywide ("Second Amendment") extending the Contract Term for a two-year period, from May 18, 2024 to May 17, 2026, and further amending the maintenance schedule and price proposal; and

WHEREAS, City and Vendor now desire to add Ocala Police Department facilities to the Agreement, as described in Exhibit D – OPD Pricing and Maintenance Schedule.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Vendor agree as follows:

- 1. **RECITALS.** City and Vendor hereby represent and warrant that the Recitals set forth above are true and correct.
- 2. **INCORPORATION OF ORIGINAL AGREEMENT**. The Original Agreement between City and Vendor, as amended, is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this Third Amendment.
- 3. **EXHIBIT D OPD PRICING AND MAINTENANCE SCHEDULE.** Vendor shall also service Ocala Police Department facilities in accordance with the pricing and frequency described in **Exhibit D OPD Pricing and Maintenance Schedule**.
- 4. **NOTICES**. All notices, certifications or communications required by this Third Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
