The products offered under Sourcewell Contract No. 040621 have been competitively solicited by Sourcewell, a State of Minnesota agency and service cooperative, and evaluated and determined by the City's Procurement Department to be cost effective and to afford City best value. On March 10, 2025 Sourcewell and Marathon exercised the renewal, thereby extending the contract term through June 2, 2026.
