



**SECOND AMENDMENT TO AGREEMENT FOR GROUNDS MAINTENANCE SERVICES AT  
800MHZ TOWER SITE**

THIS SECOND AMENDMENT TO AGREEMENT FOR GROUNDS MAINTENANCE SERVICES AT 800MHZ TOWER SITE ("Second Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City") and **SQUEEKIE KLEAN LANDSCAPING, LLC**, a limited liability company duly organized and authorized to do business in the state of Florida (EIN: 27-2913828) ("Contractor").

**WHEREAS**, on July 18, 2023, City and Contractor entered into an Agreement for Grounds Maintenance Services at 800MHz Tower Site (the "Original Agreement") City of Ocala Contract No.: OPD/230540 for a term of two (2) years from July 10, 2023, through July 9, 2025; and

**WHEREAS**, on June 13, 2025, City and Contractor entered into a First Amendment to Agreement for Grounds Maintenance Services at 800MHz Tower Site (the "First Amendment"); to extend the Original Agreement for the first of two available one-year renewals, from July 10, 2025, through July 9, 2026; and

**WHEREAS**, the City and Contractor now desire to renew the Original Agreement for the final one-year renewal period available under the Original Agreement.

**NOW THEREFORE**, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Contractor agree as follows:

1. **RECITALS.** City and Contractor hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Contractor, as amended, is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this Second Amendment.
3. **RENEWAL TERM.** The Original Agreement, as amended, is hereby renewed for an additional one (1) year term commencing **JULY 10, 2026**, and ending **JULY 9, 2027**.
4. **COMPENSATION.** Contractor shall be paid a price not to exceed the maximum limiting amount of **FOUR THOUSAND, THREE HUNDRED TWENTY AND NO/100 DOLLARS (\$4,320)** (the "Contract Sum") over the contract term as full and complete compensation for the timely and satisfactory performances of grounds maintenance services.
5. **NOTICES.** All notices, certifications or communications required by this Second Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format.
