

FIRST AMENDMENT TO AGREEMENT FOR GROUNDS MAINTENANCE SERVICES

THIS FIRST AMENDMENT TO AGREEMENT FOR GROUND MAINTENANCE SERVICES ("First Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City") and **PURE CUTS LAWN AND MAINTENANCE LLC** a limited liability company duly organized and authorized to do business in the state of Florida (EIN: 88-4098034) ("Contractor").

WHEREAS, on February 21, 2024, City and Contractor entered into an Agreement for Grounds Maintenance Services (the "Original Agreement"), City of Ocala Contract Number PWD/240103 for a term of two (2) years from March 1, 2024, through February 28, 2026; and

WHEREAS, City and Contractor now desire to amend the Original Agreement to modify one (1) service location and update the pricing schedule as set forth in **Exhibit B – Price Proposal**.

NOW THEREFORE, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Contractor agree as follows:

- 1. **RECITALS**. City and Contractor hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
- INCORPORATION TO ORIGINAL AGREEMENT. The Original Agreement between City and Contractor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
- 3. **AMENDMENT TO EXHIBIT B PRICE PROPOSAL.** The document attached to the Original Agreement as **Exhibit B Price Proposal** is hereby deleted in its entirety and replaced with **Amended Exhibit B Price Proposal**.
- 4. COMPENSATION. City shall pay Contractor an amount no greater than <u>ONE HUNDRED SIX</u> <u>THOUSAND, NINE HUNDRED ONE AND NO/100 DOLLARS (\$106,901)</u> (the "Contract Sum") over the Contract Term as full and complete compensation for the timely and satisfactory performance of services in accordance with the pricing schedule detailed in **Amended Exhibit B Price Proposal**.
- 5. NOTICES. All notices, certifications or communications required by this Agreement shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

- 8. **LEGAL AUTHORITY**. Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.
