

SECOND AMENDMENT TO AGREEMENT FOR GROUNDS MAINTENANCE SERVICES – SOUTHEAST AND SOUTHWEST RIGHTS OF WAY AND MEDIANS

THIS SECOND AMENDMENT TO AGREEMENT FOR GROUNDS MAINTENANCE SERVICES – SOUTHEAST AND SOUTHWEST RIGHTS OF WAY AND MEDIANS ("Second Amendment") is entered into by and between the <u>CITY OF OCALA</u>, a Florida municipal corporation ("City"), and <u>GAMCO PROPERTIES III, INC.</u>, a for-profit corporation duly organized and authorized to do business in the State of Florida (EIN# 46-5008833) ("Contractor").

WHEREAS, on December 15, 2020, City and Contractor entered into an Agreement for Grounds Maintenance Services – Southeast and Southwest Rights of Way and Medians (the "Original Agreement"), City of Ocala Contract Number: PWD/200660; and

WHEREAS, on May 4, 2021, City and Contractor entered into a First Amendment to Agreement for Grounds Maintenance Services – Southeast and Southwest Rights of Way and Medians (the "First Amendment") to modify the locations to be maintained by Contractor; and

WHEREAS, City and Contractor desire to further modify the locations to be maintained by Contractor as set forth in the Price Proposal attached to the Original Agreement, as amended, as Exhibit B.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Contractor agree as follows:

- 1. **RECITALS**. City and Contractor hereby represent and warrant that the Recitals set forth above are true and correct.
- INCORPORATION OF ORIGINAL AGREEMENT. The Original Agreement between City and Contractor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect except for those terms and conditions expressly amended by this Second Amendment.
- 3. **AMENDMENT TO EXHIBIT B PRICE PROPOSAL**. The document attached to the Original Agreement as Exhibit B Price Proposal is hereby deleted and replaced, in its entirety, with the document attached to this Second Amendment as **Amended Exhibit B Price Proposal**.
- 4. **NOTICES**. All notices, certifications or communications required by this Second Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified

Except as expressly set forth herein, the Original Agreement shall remain in full force and effect and is not amended or modified.
- 6. **COUNTERPARTS.** This Second Amendment may be executed in counterparts, each of which shall be an original and all of which shall constitute the same instrument.
- 7. **ELECTRONIC SIGNATURE(S).** Contractor, if and by offering an electronic signature in any form whatsoever, will accept and agree to be bound by said electronic signature to all terms and conditions of this Second Amendment. Further, a duplicate or copy of the Second Amendment
