



THIRD AMENDMENT TO AGREEMENT FOR ENVIRONMENTAL WATER TESTING SERVICES

THIS THIRD AMENDMENT TO AGREEMENT ENVIRONMENTAL WATER TESTING SERVICES (“Third Amendment”) is entered into by and between **CITY OF OCALA**, a Florida municipal corporation (“City”), and **PACE ANALYTICAL SERVICES, LLC**, a limited liability company duly organized in the state of Minnesota and authorized to do business in the state of Florida (EIN# 41-1821617) (“Vendor”).

WHEREAS, on October 26, 2021, City and Vendor entered into an Agreement for Environmental Water Testing (the “Original Agreement”), City of Ocala Contract Number: WRS/210139, for a term of three (3) years, from October 1, 2021, to September 30, 2024; and

WHEREAS, on November 7, 2023, City and Vendor entered into a First Amendment to Agreement to increase the total contract expenditure due to changes in federal and state testing requirements (the “First Amendment”); and

WHEREAS, on September 23, 2024, City and Vendor entered into a Second Amendment to Agreement for the first of two (2) one-year renewals available under the Original Agreement and to modify the pricing schedule for the Renewal Term (the “First Amendment”); and

WHEREAS, City and Vendor now desire to extend the Original Agreement, as amended, for the final one-year renewal term available under the Original Agreement and to increase the pricing schedule by 3% for the Renewal Term.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Vendor agree as follows:

1. **RECITALS.** City and Vendor hereby represent and warrant that the Recitals set forth above are true and correct.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Vendor, as amended, is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this Third Amendment.
3. **RENEWAL TERM.** The Original Agreement is hereby renewed for an additional one (1) year term beginning on **OCTOBER 1, 2025**, and terminating **SEPTEMBER 30, 2026**.
4. **COMPENSATION.** The highest total compensation payable to Vendor by City under this Third Amendment for the satisfactory performance of services in compliance with **Exhibit A – Scope of Work** and the Contract Documents shall be **ONE HUNDRED FIVE THOUSAND AND NO/100 DOLLARS (\$105,000)** over the Renewal Term. Compensation paid to Vendor shall be paid in accordance with the unit pricing schedule set forth below:



Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. To withdraw your consent with City of Ocala - Procurement & Contracting

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to contracts@ocalafl.org and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..
