As a political subdivision of the state of Florida, the City of Ocala qualifies as an eligible user of contracts awarded by the State of Florida Department of Management Services (DMS). Contract No. 25172500-24-ACS was approved as an alternate contract source by the State of Florida for the provision of tires, tubes and services on July 1, 2024 for a term of three years ending June 30, 2027. In the underlying NASPO solicitation, responses were received from Bridgestone Americas, Continental Tire, Goodyear Tire, and Michelin North America. All four contractors received awards under the agreement. The state of Florida has signed a participation agreement with Michelin North America and Goodyear Tire. Discounted pricing offered by the vendors will be extended and guaranteed to political subdivisions of the state of Florida. This purchase will exceed \$50,000.
