Motion amended: Approve a New Construction Incentive Program grant (CRA24-45676) to Eunus Enterprises, LLC for the construction of a 16-unit residential development in the West Ocala Community Redevelopment Agency subarea in the amount of \$165,000 including a 20-year affordability component

Director of Planning Aubrey Hale discussed a grant application for Eunus Enterprises, LLC. The grant funds will be allocated towards the construction of a sixteen-unit residential development project. The requested grant amount is \$165,000; staff recommends approval.

Pro Tem Dreyer questioned the timeframe for the affordability component. She recommends adding a 20-year time frame for affordability units.

Mr. Hale noted the grant requires the applicant to comply with reporting requirements.
