BACKGROUND:

Ocala Fiber Network recommends the use of Service and Technology Network Solutions, Inc. for the installation of aerial fiber optic cable. This work is for the expansion of the fiber infrastructure to meet the increasing customer growth within Ocala and Marion County.

FINDINGS AND CONCLUSIONS:

On September 30, 2020, the Procurement Department issued an Invitation to Bid (ITB) OFN/200700 for ongoing fiber optic cable installation. The City received six (6) bids, of which Service and Technology Network Solutions, Inc. from Ocala, FL was the lowest responsive and responsible bidder. The bid price is for all labor and supplies to install fiber optic cable as needed and priced per foot. The contract allows for two optional, one-year renewals.
