

**FIRST AMENDMENT TO AGREEMENT FOR EMERGENCY DEBRIS REMOVAL SERVICES -
PRIMARY**

THIS FIRST AMENDMENT TO AGREEMENT FOR EMERGENCY DEBRIS REMOVAL SERVICES - PRIMARY ("First Amendment") is entered into by and between **CITY OF OCALA**, a Florida municipal corporation ("City"), and **CERES ENVIRONMENTAL SERVICES, INC.**, a foreign for-profit corporation duly organized in Minnesota and authorized to do business in the State of Florida (EIN# 41-1816075) ("Contractor").

WHEREAS, on June 19, 2018, City and Contractor entered into an Agreement for Emergency Debris Removal Services - Primary (the "Original Agreement"), City of Ocala Contract Number: PWD/18-011A, for a term of three years from June 20, 2018 to June 19, 2021; and

WHEREAS, City and Contractor now to desire to extend the Original Agreement, as written, for the first of two one-year renewal periods available under the Original Agreement.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Contractor agree as follows:

1. **RECITALS.** City and Contractor hereby represent and warrant that the Recitals set forth above are true and correct.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Contractor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
3. **RENEWAL TERM.** The Original Agreement is hereby renewed for an additional one-year term beginning **JUNE 20, 2021** and terminating **JUNE 19, 2022**. Thereafter, the parties acknowledge and agree that there remains the option for the Original Agreement to renewed for one (1) additional one-year (1-year) period upon written agreement between the parties.
4. **NOTICES.** All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by email. All notices shall be addressed to the respective parties as follows:
