

FIRST AMENDMENT TO AGREEMENT FOR ANNUAL SIDEWALK MAINTENANCE AND REPAIR SERVICES

THIS FIRST AMENDMENT TO AGREEMENT FOR ANNUAL SIDEWALK MAINTENANCE AND REPAIR SERVICES ("First Amendment") is entered into by and between **CITY OF OCALA**, a Florida municipal corporation ("City"), and **MARCUM ENTERPRISES**, **LLC**, a limited liability company duly organized and authorized to do business in the State of Florida (EIN# 45-4248175) ("Contractor").

WHEREAS, on May 7, 2020, City and Contractor entered into an Agreement for Annual Sidewalk Maintenance and Repair Services (the "Original Agreement"), City of Ocala Contract Number: PWD/200074 for a term of two (2) years, from May 5, 2020 to May 5, 2022; and

WHEREAS, City and Contractor now desire to extend the Original Agreement, as amended, for the single one-year renewal period available under the Original Agreement and to amend Exhibit B – Price Proposal to reflect a three percent (3%) price increase.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Contractor agree as follows:

- 1. **RECITALS.** City and Contractor hereby represent and warrant that the Recitals set forth above are true and correct.
- INCORPORATION OF ORIGINAL AGREEMENT. The Original Agreement between City and Contractor, as amended, is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
- 3. **EXTENSION**. The Original Agreement is hereby renewed for an additional one-year term beginning **MAY 6, 2022** and terminating **MAY 5, 2023**.
- 4. AMENDMENT TO EXHIBIT B PRICE PROPOSAL. The document attached to the Original Agreement as Exhibit B – Price Proposal, as amended, is hereby deleted and replaced, in its entirety, with the document attached to this First Amendment as Amended Exhibit B – Price Proposal.
- 5. **NOTICES**. All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.
