Will there housing for the elderly?

Response: There isn't anything age-restricted slated at this time.

Will there housing for the handicap?

Response: Apartments will meet city building requirements. There will be handicap accessible parking.

What type commercial do you foresee on NW 35th St.? How many acres out of the entire project is dedicated to commercial.

Response: (7) 1 Ac. out of 216 Ac. We anticipate there to be smaller commercial, something to serve the community. We anticipate stores like a Walgreens or something similar to that nature to be built.

Define "affordable" housing?

Response: The response was deferred to David Boston, city Planning and zoning Manager. The average prices we are anticipating are \$155,000 -\$200,000.

Define "stakeholders"

Response: We view the community surrounding the development as stakeholder. We want this development to fit in with this community. We want them to identify any concerns so that we can make changes to our plans.

Will the homes be electric or gas?

Response: City of Ocala electric

Will the homes be solar powered?

Response: No. Solar power has not be slated at this time.

Will there be well and drainage fields or city water and sewer?

Response: City of Ocala water and sewer.

With the given the history about the golf course, has there been any thought of changing the name of roads, parks or buildings?

Response: 911 management uses a number grid system, so road name changes will require waivers. Park and buildings names are much easier to change.

Has there been any thought about using local contractors/ builders?

Response: Yes. West Oak Developer LLC. is open to using local contractor / builders. Everyone that West Oak Developers LLC. hired are Ocala-based.

Has there been any thought of buffering from Friends recycling?

Response: The existing vegetation around the perimeter will be preserved to provide a buffer.

What is the total units anticipated?

Response: 1,250 +/- (300 single family + 300 multi-family + 650 apartments)

Will there be parking for the apartments?

Response: We will adhere to the City of Ocala on-street and off-street parking requirements.

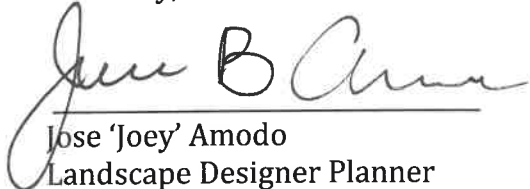
To Whom It May Concern,
