 to the other, the parties agree to a renewal of said original Agreement for a period beginning the 27th day of February, 2021
 and ending the 26th day of February, 2024 at a cost of \$46,425.00.

All terms and conditions of said original Agreement shall remain in force and effect for this renewal.
