

FIRST AMENDMENT TO AGREEMENT FOR PROFESSIONAL ELECTRIC TRANSMISSION DESIGN AND ENGINEERING SERVICES

THIS FIRST AMENDMENT TO AGREEMENT FOR PROFESSIONAL ELECTRIC TRANSMISSION DESIGN AND ENGINEERING SERVICES ("First Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City") and **GAI CONSULTANTS, INC.**, a for-profit corporation duly organized in the state of Pennsylvania and authorized to do business in the state of Florida (EIN: 25-1260999) ("Consultant").

WHEREAS, on January 18, 2023, City and Consultant entered into a Services Agreement for Professional Electric Transmission Design and Engineering Services (the "Original Agreement"), City of Ocala Contract No.: ELE/211020, for a term of three (3) years from December 6, 2022, through December 5, 2025; and

WHEREAS, City and Consultant now desire to extend the Original Agreement for the sole two-year renewal term under the Original Agreement.

NOW THEREFORE, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Consultant agree as follows:

- 1. **RECITALS**. City and Consultant hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
- 2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement, between City and Vendor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
- 3. **RENEWAL TERM.** The Original Agreement, as amended, is hereby renewed for a two (2) year renewal term beginning on **DECEMBER 6, 2025,** and terminating **DECEMBER 5, 2027.**
- 4. **COMPENSATION.** City shall pay Consultant a price not to exceed **TWO MILLION, FIVE HUNDRED THOUSAND AND NO/100 DOLLARS (\$2,500,000)** (the "Contract Sum") over the Renewal Term as full and complete compensation for the timely and satisfactory provision of services.
- 6. NOTICES. All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.
