

## SECOND AMENDMENT TO AGREEMENT FOR GROUNDS MAINTENANCE SERVICES – DRAINAGE RETENTION AREAS

THIS SECOND AMENDMENT TO AGREEMENT FOR GROUNDS MAINTENANCE SERVICES – DRAINAGE RETENTION AREAS ("Second Amendment") is entered into by and between **CITY OF OCALA**, a Florida municipal corporation ("City"), and **EASON LAWN SERVICE, LLC**, a limited liability company duly organized and authorized to do business in the state of Florida (EIN: 30-0541940) ("Contractor").

**WHEREAS**, on April 8, 2020, City and Contractor entered into an Agreement for Grounds Maintenance Services – Airport Terminal (the "Original Agreement"), City of Ocala Contract Number: AIR/200063B; and

**WHEREAS**, on April 11, 2022, City and Contractor entered into a First Amendment to Agreement for Grounds Maintenance Services – Drainage Retention Areas ("First Amendment") to renew the term of the Original Agreement for an additional one-year term from April 1, 2022 to March 31, 2023; and

**WHEREAS**, City and Contractor desire to extend the Original Agreement, as written, for the final one-year (1-year) renewal period available under the Original Agreement.

**NOW THEREFORE**, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Contractor agree as follows:

- 1. **RECITALS.** City and Contractor hereby represent and warrant that the Recitals set forth above are true and correct.
- 2. **INCORPORATION OF ORIGINAL AGREEMENT**. The Original Agreement between City and Contractor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this Second Amendment.
- 3. **RENEWAL TERM**. The Original Agreement is hereby renewed for an additional one-year term beginning **APRIL 1, 2023** and terminating **MARCH 31, 2024**.
- 4. **NOTICES**. All notices, certifications or communications required by this Second Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by email. All notices shall be addressed to the respective parties as follows:


