

# BUDGET RESOLUTION 2021-163

## A RESOLUTION AMENDING THE FISCAL YEAR 2020-2021 BUDGET TO ALLOCATE FUNDS FROM THE AMERICAN RESCUE PLAN ACT TOTALING \$6,101,071

**WHEREAS**, on January 20, 2020, the Secretary of Health and Human Services declared a public health emergency under section 319 of the Public Health Service Act (42 U.S.C. 247d); and

**WHEREAS**, on March 11, 2020, the World Health Organization announced that the COVID-19 outbreak can be characterized as a pandemic; and

**WHEREAS**, on March 11, 2021, President Joseph R. Biden, Jr. enacted the American Rescue Plan Act; and

**WHEREAS**, on May 18, 2021, City Council approved a subaward and grant agreement related to the American Rescue Plan Act; and

**WHEREAS**, the American Rescue Plan Act revenue will be used to recover loss revenue in the General Fund totaling \$2,072,589 for fiscal year 2020; and

**WHEREAS**, the American Rescue Plan Act revenue will be used to fund up to \$600,000 for the Community Foundation's network of non-profit businesses within our community and specially designated pre approved projects of which all must comply with all requirements within the American Rescue Plan Act interim rules and funding regulations; and

**WHEREAS**, the American Rescue Plan Act revenue will be used to fund the City of Ocala Water/Sewer capital projects expenditures totaling \$3,428,482.

**NOW THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA**, duly assembled in regular session, that the FY2021 budget be amended as outlined below:

### **BACKGROUND:**

On March 11, 2021 the American Rescue Plan Act (ARPA) was signed. This act provides for specific funding allocations directly to state, local, and municipal government agencies. The total allocation for the City of Ocala is estimated at \$12,202,141. The funds are scheduled for disbursement with fifty percent (50%) \$6,101,070.50 received on June 1, 2021 and the remaining fifty percent (50%) in June 2022. Recovery funds must be obligated (not incurred) by December 31, 2024 and all work and/or services completed by December 31, 2026.

The ARPA provides that funding may be used to:

- 1) Support public health expenditures, by, for example, funding COVID-19 mitigation efforts, medical expenses, behavioral healthcare, and certain public health and safety staff.
- 2) Address negative economic impacts caused by the public health emergency, including economic harms to workers, households, small businesses, nonprofits, impacted industries, and the public sector.
- 3) Replace lost public sector revenue, using this funding to provide government services to the extent of the reduction in revenue experienced due to the pandemic.
- 4) Provide premium pay for essential workers, offering additional support to those who have and will bear the greatest health risks because of their service in critical infrastructure sectors.
- 5) Invest in water, sewer, and broadband infrastructure, making necessary investments to improve access to clean drinking water, support vital wastewater and stormwater infrastructure, and to expand access to broadband internet.

### **FISCAL IMPACT:**

ARPA grant revenue totaling \$6,101,071, as detailed below, staff's recommendation is to allocate the funding to support fiscal year 2020 General Fund loss of revenue, fiscal year 2021 Water/Sewer capital expenditures, and relief request for Community Foundation.
