#### **BACKGROUND:**

The Ocala Police IT Department is requesting approval to proceed with the annual renewal of its Computer Aided Dispatch (CAD) software with Computer Information Systems, Inc (CIS). The Ocala Police Department has been utilizing CIS's CAD software since July 2007. The software is responsible for dispatching emergency medical service, fire, and police services to emergency and non-emergency calls. This software is all-inclusive for calls for service, records, evidence management, and interfacing with external entities, and other internal software programs.
