BACKGROUND:

The Municipal Arts Commission shall consist of eleven members appointed by City Council for four-year terms. Appointments shall be made based on experience and interest in the cultural arts at the sole discretion of City Council. Whenever possible, the membership shall include a representative member from the College of Central Florida's Visual and Performing Arts Department, Fine Arts for Ocala (FAFO), Marion County School Board, Marion Cultural Alliance (MCA), Ocala Civic Theater, and the Ocala Symphony Orchestra.

The terms for Dr. Allen Danuff, (College of Central Florida representative), Brooke Hutto (Ocala Civic Theatre representative), Darian Mosley (experience and interest in cultural arts), and David Reutter (Fine Arts For Ocala representative), expire March 1, 2024.
