FINAL ADMINISTRATIVE ORDER

THIS CAUSE, came for public hearing before the Municipal Code Enforcement Board on April 11, 2024, after due notice to the Respondent(s), and the Municipal Code Enforcement Board having heard testimony under oath, received evidence, considered stipulations, and heard argument, thereupon issues its Final Administrative Order, Findings of Fact, Conclusion of Law, and Notice of Hearing on Compliance, and Imposition of Fines as follows:

I. FINDINGS OF FACT:

A. The Respondent(s), **MARION COUNTY JCB HOLDINGS LLC**, owner(s) in charge of the property described as: **2260-108-010 | 1700 BLK SW 1ST ST, OCALA, FLORIDA** recorded in the Public Records of Marion County, Florida.

B. That on and between February 27, 2024, and April 11, 2024, the property, as described above, was in violation of the City of Ocala Code of Ordinances, Section 34-95 - Weeds; accumulations of trash or other unsightly or unsanitary matter.

II. CONCLUSION OF LAW:

A. 

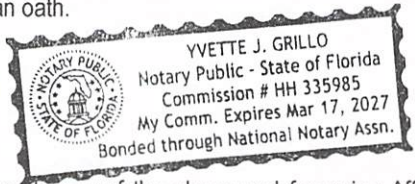

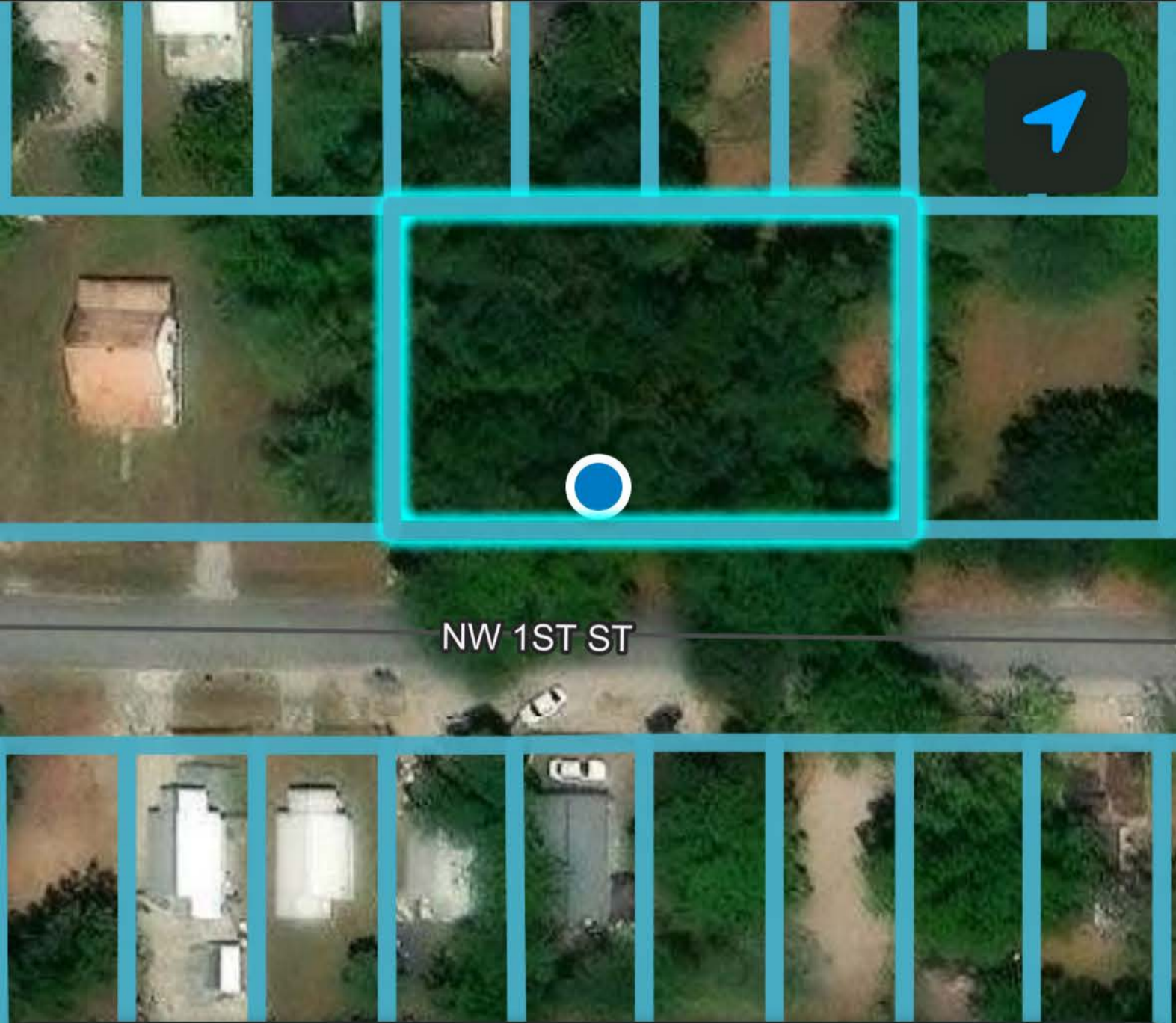
