

ORDER GRANTING EXTENSION OF TIME NOTICE OF HEARING ON COMPLIANCE AND IMPOSITION OF FINES

THIS CAUSE, came for public hearing before the Code Enforcement Special Magistrate on July 31st, 2024, after due notice to the Respondent(s), and the Code Enforcement Special Magistrate having heard testimony under oath, received evidence, considered stipulations, and heard argument, thereupon issues its Final Administrative Order, Findings of Fact, Conclusion of Law, and Notice of Hearing on Compliance, and Imposition of Fines as follows:

I. PREVIOUS FINDINGS OF FACT: <u>DATED JUNE 3RD, 2024</u>

- A. The Respondent(s), KESSEL, ROBERTA, owner(s) in charge of the property described as: 2618-003-033 I 1123 NE 9TH AVE OCALA, OCALA, FLORIDA recorded in the Public Records of Marion County, Florida.
- **B.** That on and between March 22, 2024 and May 29, 2024 the property, as described above, was in violation of the City of Ocala Code of Ordinances, Section 34-95 Weeds; accumulations of trash or other unsightly or unsanitary matter.

11. PREVIOUS CONCLUSION OF LAW: DATED JUNE 3RD, 2024

A.
