5. The prosecution costs of \$294.07 have NOT been paid.

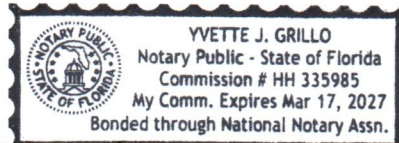


