

STAFF RECOMMENDATION	DALE HOLLINGSWORTH	8/4/2025	8/4/2025	Find "Larry Dean Heier" guilty of violating city code sections: 22-151(b)(6) by engaging in the business or acting in the capacity of a contractor, advertising oneself or business organization as available to be engaged in business, or acting in the capacity of a contractor without being duly registered or certified; 22-151(b)(8) by commencing or performing work for which a building permit is required pursuant to any appliable building code provisions without such permit being in effect; and 1.) Pay a fine to the City of Ocala Code Enforcement Division in the amount of \$100.00 per violation for a total of \$200 by 4:00pm on Thursday, September 4th, 2025. 2.) Pay the cost of prosecution to the City of Ocala Code Enforcement Division in the amount of \$180.97 by 4:00pm on Friday, September 4th, 2025. A certified copy of this order imposing a civil penalty may be recorded in the public records and thereafter shall constitute a lien against any real or personal property owned by the violator. After three months from the filing of any such lien which remains unpaid, the contractor's board of examiners and appeals may authorize the city attorney to foreclose on

						On this date at approximately 1430 hours, I was in the area of 925 SE 17th Street when I observed what appeared to be a new wood roof structure on the roof of the commercial business at that location. After a check of the permitting database, no permits were discovered for work; therefore, I proceeded to the location and made contact with two individuals outside next to a construction lift. One individual identified herself as the property owner, and the other identified himself as Larry Heier, who was later determined to be performing the work. After conversation regarding my observations, the property owner invited me

INITIAL	RDH	7/16/2025	7/16/2025	COMPLETED	upstairs to have a closer view of the work, which was determined to be the construction of a roof awning to protect a skylight from rain. This was due to the glass skylight area leaking, but they confirmed this was to be a permanent structure. I contacted the Building Department's Project Manager, Greg McClellan, who responded and also inspected the work. His inspection confirmed the work required a licensed contractor and permitting. Additional conversation with Mr. Heier revealed he had construction industry knowledge but was not a licensed contractor. He also advised he was not being paid for the job but was rather a friend and simply helping since he knew how to perform the work. During conversation about the specific work, Mr. Heier made statements confirming he was in fact physically involved with performing the construction work on site. Mr. Heier was explained the violations he committed and the penalties and informed a Notice of Hearing would be sent certified mail to him at his residence of record. He indicated he understood. The property owner is being afforded a reasonable time to obtain engineering and a contractor to obtain permits before formal enforcement action will be pursued against her as the property owner.

(2) Impose a fine of not more than \$500.00 per violation per day, up to a maximum of \$5,000.00 per day when multiple violations exist. LICENSED CONTRACTOR: (1) Reprimand the holder of the certificate. (2) Suspend any certificate holder who has obtained his certificate of competency from the city of the county, or through reciprocity, from all operations of construction for a period of not less than 30 days and not more than five years. (3) Suspend the permitting privileges of a certificate holder who has obtained his certification or registration from the state. The suspension shall remain in effect for a period of not less than 30 days and not more than five years. (4) Revoke the certificate of a certificate holder who has obtained his certificate of competency from the city or through reciprocity. (5) Revoke the permitting privileges of a certificate holder who has obtained his certification or registration through the state. (6) Bar the issuance or renewal of a certificate held by a certificate holder who has obtained his certificate of competency from the city or through reciprocity or bar the renewal of permitting privileges of a certificate holder who has obtained his certification or registration from the (7) Require that restitution be provided to any party aggrieved by a violation of any provision of this article. (8) Impose a fine of not more than \$500.00 per violation per day, up to a maximum of \$5,000.00 per day when multiple violations exist. NOTE: Both licensed and unlicensed contractors may also be assessed a fee corresponding to the reasonable investigative and legal costs incurred by the city in prosecuting any violation against the person. Each day a willful, knowing violation continues shall constitute a separate offense under the provisions of this section and shall be punishable as such. For purposes of this section, a violation shall be deemed to commence on the date the violation first occurs.
