



I. FINDINGS OF FACT:

- A. The Respondent(s), EXIT STRATEGY MAY 13 LLC, owner(s) in charge of the property described as 2260-168-006 / 2117 NW 1ST ST, Ocala, Florida recorded in the Public Records of Marion County, Florida.
- B. That on and between August 21st, 2025, and October 28th, 2025, the property, as described above, was in violation of the City of Ocala Code of Ordinances, SECTION 34-95 WEEDS ACCUMULATIONS OF TRASH OR OTHER UNSIGHTLY OR UNSANITARY MATTER.
