Planner II, Breah Miller, provided a brief overview of the request for a prefabricated Victorian style greenhouse with a brick base, wrought iron gazebo, expansion of the existing pool deck, two circular brick patios and installation of landscaping for the property at 1140 E. Fort King Street.

Robert Jenkins, 1140 E. Fort King Street, Ocala, FL, said the picture of the greenhouse looks larger, and it is not a conceptual picture. The meadow between the two homes are to plant native wildflower seeds to reduce the need for mowing and irrigation. Mr. Jenkins said he would like to tweak the language to say combine or reconfigure existing lots.

Ms. Cosand asked if he owned the two homes. Mr.Jenkins replied he owned the three homes.

Ms. Townsend asked if it was possible for the applicant to ask for a variance. Ms. Miller replied no because of the accessory structure.

Ms. Ausley stated that the condition was beyond OHPAB. Ms. Miller replied that the reason the condition is on the staff report is because there have been zoning issues in the past. The Staff is recommending approval for this addition because it does meet the zoning regulations. Mr. Jenkins can get approval for OHPAB, but if he wants to put the gazebo and not do the lot reconfiguration, he will be stopped. Ms. Miller stated that combination or lot reconfiguration are on the same application so it would be okay to reword the report.

Ms. Cosand asked how can it be approved with conditions so that the applicant can move forward. Ms. Miller replied that she can say, "as is with the understanding that it is for combination or lot reconfiguration."

The windows have to be pressed out into the plane of the building and the windows should have no shadow line. Mr. Tory stated the it is very important to have the windows as far back into the building and have a shadow line. Ms. Cosand asked if the windows where going to be set back. Ms. Miller replied that the way the window is constructed there is no other way. Mr.McCullough asked if the windows are going to be placed where the windows are now, with no deviation. Mr. Cabreja replied yes, and the replacement windows are going exactly

where the original windows are now.
