Emily:

I spoke with Travis Barrineau, Surveyor of Record on behalf of Lake Louise, LLC, concerning the descriptions he previously prepared to describe the portions of public rights-of-way intended for abrogation pursuant to the above referenced application. Travis confirmed to me that the intent by the applicant is to essentially abrogate the portions that lie within the boundaries of Parcels 1 through 4, inclusive, as shown on the Boundary Survey that accompanied the application (copy attached here for your benefit).

Due to complications caused by the geometric elements of rights-of-way, lots, etc., established by the plats of Lake Louise Estates, Lake Louise Manor and First Addition to Lake Louise Manor, the description initially produced by Travis towards the goal of using a simple approach (which frequently work for these applications) creates ambiguities in interpretation as to the intended portion of rights-of-way to be abrogated. As a result, I am of the opinion that this approach had to be modified somewhat in order to produce descriptions that remove the ambiguities and potential for uncertainty by those who will be required to interpret the description to understand the limits of lands which will be subject to the official action of the city, assuming the application is approved.

I took the liberty of preparing a draft version of the approach I think suitably addresses my concerns. As descriptions for the above referenced Parcels 1 through 4 had been previously provided by the applicant in metes and bounds format, I utilized those where appropriate to qualify the portions proposed for abrogation. This was further complicated a bit as a result of Resolution 2022-54 (OR Book 7894, page 1627), previously executed by the city and affecting some of the rights-of-way within Parcel 3. For that reason, those applicable segments also

include an exception for the portions previously vacated by the resolution.

I also performed computational analysis of the metes and bounds descriptions of Parcels 1 and 3 as provided with the application. The description of Parcel 1 appears to have a dimensional error resulting in a misclosure of 1.00 foot. After some comparison to the plats, I have highlighted the most likely segment of the description to contain the error in red within the Parcel 1 description. In addition, I supplemented the preamble of both Parcels 1 and 3 to include those segments of right-of-way that lie between the referenced lots or portions thereof that are included in each parcel.

It's taken a bit of time to get through this today, but I believe the description should be sufficient once Travis confirms or corrects the dimensional error within the Parcel 1 description. It would also be appropriate for him to perform a general cursory check of the description to ensure we're both on the same page as to the suitability of this description to describe the relevant portions of public rights-of-way sought for abrogation pursuant to this application.

In addition to the ones referenced above, I've included the other relevant documents that may be beneficial to you concerning the draft of the revised description. Once Travis deals with the apparent dimensional error in the Parcel 1 description, and assuming he is good with the approach and format of the balance of the description, Emily should be able to proceed with the balance of the process.

Emily:

I finally got to your email a little while ago to begin to review your request. Contrary to your email, I didn't find the application attached, only the description in MS Word format and a copy of the survey. From a cursory review, it appears that the applicant is requesting to abrogate the public rights-of-way that lie with the limits of Parcels 1 through 4, inclusive. However, the description as written does not describe any reference to the rights-of-way that you describe in your email but they do generally appear to agree with the extent of the lands shown on the Boundary Survey. We are slammed here in survey and the timing of this request with the holiday and my schedule further challenges the review.

It will take a good bit of time for me to conduct a thorough review of the description provided. Unfortunately, I will be out of the office next week and am scheduled to return on Tuesday, December 2. Consequently, I'm reaching out to inform you of my quick findings so you can contact the applicant about the deficiency unless there is more information that you haven't shared with me that may actually describe the rights-of-way that are intended for abrogation.

I will be checking email from time to time and will look for a reply from you. That said, the best I can offer at this point is to dive into this when I return to the office and push to get through it as quickly as I can, but it will take several hours at a minimum.

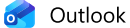

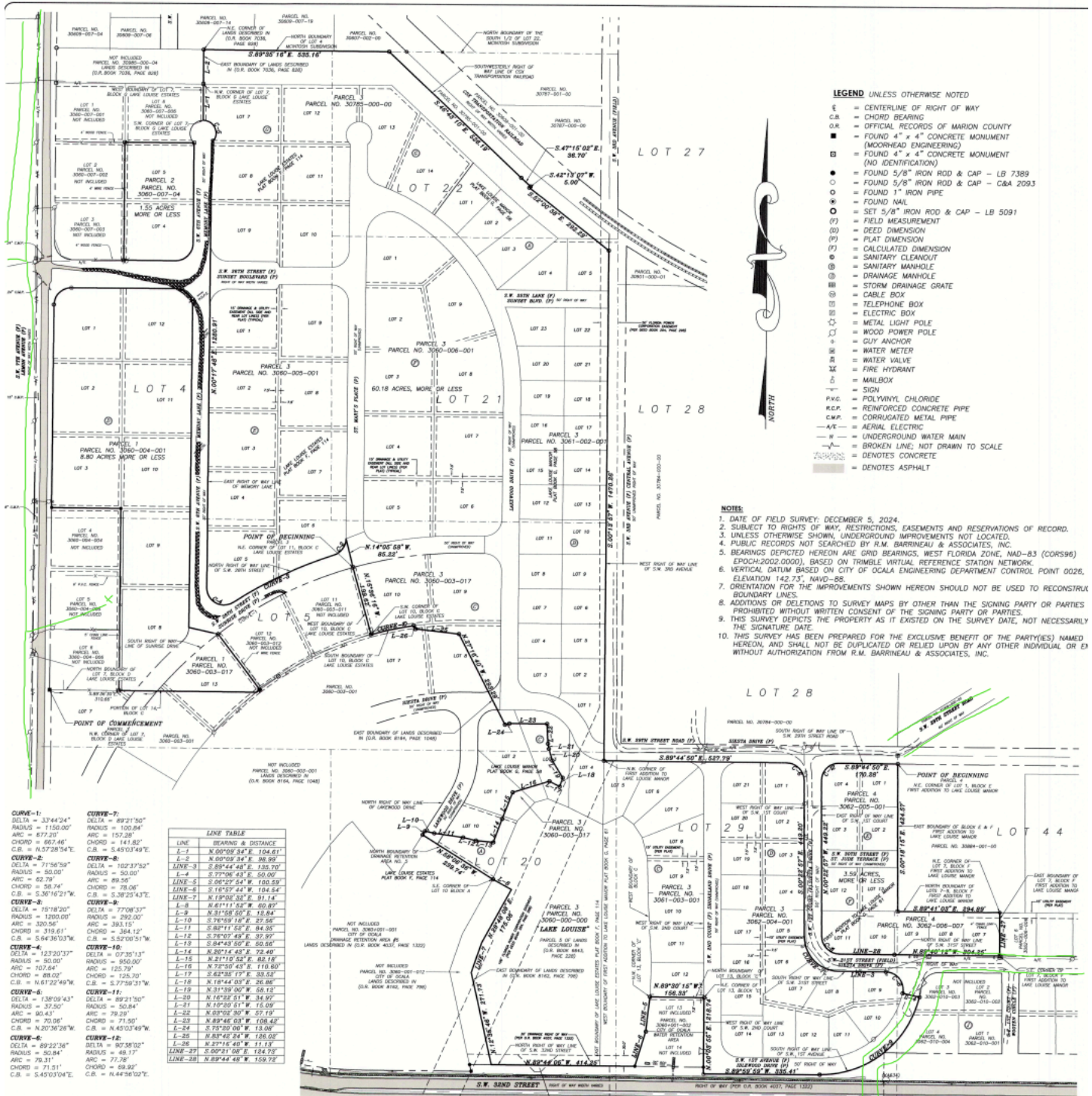
