

STAFF RECOMMENDATION	DALE HOLLINGSWORTH	4/24/2025	4/24/2025	<p>Find "PIM Construction Services LLC" guilty of violating city code sections:</p> <p><b>22-151(b)(1) - Falsely advertising or holding oneself or a business organization out as a contractor or journeyman;</b></p> <p><b>22-151(b)(6) - Engaging in the business or acting in the capacity of a contractor advertising oneself or a business organization as available to be engaged in business, or acting in the capacity of a contractor without being duly registered or certified; and</b></p> <p><b>22-151(b)(12) - Disregarding any municipal ordinance relating to unlicensed or unregistered contractors.</b></p> <p><b>1.) Pay a fine to the City of Ocala Code Enforcement Division in the amount of \$500 per violation, for a total fine of \$1,500 by 4:00pm on Friday, June 5th, 2025.</b></p> <p><b>2.) Pay the cost of prosecution to the City of Ocala Code Enforcement Division in the amount of \$383.91 by 4:00pm on Friday, June 5th, 2025.</b></p> <p>A certified copy of this order imposing a civil penalty may be recorded in the public records and thereafter shall constitute a lien against any real or personal property owned by the violator. After three months from the filing of any such lien which remains unpaid, the contractor's board of examiners and appeals may authorize the city attorney to foreclose on the lien.</p>
