RE: FY2024 Budget Update

The information below is intended to give a concise overview of the latest budgetary activities in the current fiscal year. See Table 1 for the consolidated FY24 North Magnolia CRA budget. The updates provided primarily relates to grants and Capital Improvement Projects (CIP). The CRA has approved ten (10) grants between FY22-FY24, of this amount seven (7) projects were completed and three (3) are still ongoing. A balance of \$48,460 is available for future grant applications. See Table 2 for a summary of the grant applications processed.

Imagine North Magnolia continues to be the main area of focus in the subarea. The recent completion of the neighborhood park, water, sewer and road infrastructure improvements in the Marion Heights Neighborhood marks a significant milestone in this community redevelopment project. The Imagine North Magnolia Project Budget covers items such as Land acquisition, professional services, code enforcement/demolition, Infrastructure improvements, other aids and grants. The recently completed infrastructure improvements have an estimated project cost of \$1,153,331.25. Of the total amount, the CRA will pay \$805,005. To date the CRA has paid \$556,092.66 to the vendor. The balance of \$266,589.17 is to be paid in FY24. The Engineering Department will also cover a portion of the cost (\$348,326.25). See Table 3.
